- 2) Food Vendors **must** also obtain a Temporary Food Establishment Permit (\$20-\$50) from the NYC Licensing Center, located at 42 Broadway, 5th Floor in Manhattan. Bring a copy of this application when you apply for your permit. **This year, our NYC Street Activity Permit # 6 8 5 6 8 4**

### Insurance Deadlines and The Agreement

We understand that we are obliged to staff our booth for the entire day: from registration at 9:00 am (**booth setup and registration must be completed by 10:00 am**) to breakdown beginning at 5:00 pm (**breakdown must be completed by 5:30 pm**) We further understand that we must obtain a Temporary Food Establishment Permit, if we sell food.

We agree to comply with the provisions in this application about space regulations, licenses, permits, and insurance, and we agree to comply with the rules and regulations of the Loisaida Festival.

The applicant shall indemnify and hold Loisaida, Inc. its employees and board members harmless from and against any loss, damage or expense, including attorneys fees, as a result of any claim, demand, suit or proceedings made or brought against Loisaida, Inc., its staff and/or board members based upon or as a result of any acts, errors, or omissions of applicant, and from and any claims, demands, or suit proceedings brought against Loisaida, Inc., its staff and board members in connection with the Loisaida Festival, to be held on **Sunday, May 28<sup>th</sup> 2023**.
